



## Patient no1 Results:

## The UK's Online Safety Act: An Excellent First Step

On 1 August 2025, the civilised world witnessed a wonderful and monumental first step towards building a better future for our children, and, by extension, ourselves and generations to come.

This monumental first step came in the form of the UK's precedent-setting Online Safety Act finally coming into full legal effect; this Act is a truly groundbreaking piece of bipartisan, well-supported lawmaking. This highly effective Act aims to protect our children from the exploitative, unregulated Wild West they are forced to navigate each and every day: the internet.

The first part of this Act that we wish to cover is the courageous, government-mandated removal of content that is not child-safe. Video-sharing platforms, search engines, and other similar websites will be mandated to remove content that is non-compliant with the government's strict child-safe guidelines. This policy ensures that no child will ever come into contact with something that could damage their young and fragile mind. This is enforced with either a £18m fine or 10% of global revenue, five years of prison time, and/or blocking of the site in the UK. This will also incentivise the mass removal of content that does not strictly break the UK's guidelines but could be potentially misconstrued as doing so, which is an unintended yet excellent side effect.

Now, despite all these positives, at The Gadfly we feel that this is not nearly enough. This flawed 'innocent-until-proven-guilty' model does not work. The only logical endpoint of the government's harm-reduction strategy is a government-controlled whitelist that disallows not only content that might be harmful but also content that is simply unhelpful. This ensures that every digital step a child takes online will fall only on morally correct and helpful ground. We also suggest making the fine larger (Perhaps £500m/50% global revenue, whichever is higher) to incentivise even stricter enforcement of government rules by companies. These proposed changes should produce a drastic improvement in child safety in the coming years. Together, with our suggestions, we can build a better world for everyone.

The UK government also plans to utilise age-verification technology backed by photo-based government IDs for anyone who wishes to visit a site that is not completely curated for young children. Again, while this is a good first step, it will largely be ineffective; this system is riddled with childish simple (not a good thing when you are blocking children) loopholes. A determined child can easily borrow their parent's phone; they could take their mother's ID, or be brainwashed and misled by foreign agents into purchasing a VPN in the name of 'privacy' (Privacy: a selfish indulgence that directly enables predators and puts our children at risk). No, these initial plans are not nearly enough to protect the children fully.

All these loopholes are rendered obsolete with a simple and elegant solution. The internet must be treated not like a town square but like a secure primary school, with keycards to get in and out of the building so as to protect our children. As such, we suggest implementing the digital equivalent: a 'digital passport' system (the logical next step, already being discussed around the world) where, to log in to the internet, you must provide a government-issued digital passport that identifies you to your internet service provider, the government, and any website you wish to visit. Not only will this prevent children from being harmed, but it also means you will no longer need to fear anonymity on the internet. Undesirables who are disruptive in the eyes of the government will be blocked from the internet as a whole, cleaning up the digital square and ensuring safety for all. The children will only ever be safe from predators and exploitative practices when each citizen has a mandatory digital ID and everyone is accounted for.

Most courageously, this Act confronts the vile technology of end-to-end encryption. For too long, we have tolerated the absurd myth that privacy is a fundamental human right.

What, after all, does an honest, child-loving citizen have to hide from the UK's benevolent government? However, we see a disappointing level of hypocrisy. While the state rightly demands a master key to every citizen's life, it intends to leave its own communications securely locked. This is totally unacceptable; privacy is deserved by no one. Just as your average citizen could easily be communicating CSAM, so could a government employee.

This perhaps explains the UK government's childlike analogy of 'sniffing' end-to-end encrypted communications: a commendable idea, but fundamentally at odds with how encryption actually works. It is an understandable and common mistake to make, as technology is rather difficult to understand. Reading Wikipedia (especially after we make it an unviable platform—good riddance) is rather hard. More importantly, this analogy lacks the imagination required to protect our children properly. A sniffer tool would be for finding hidden secrets shared between individuals, but why stop there? A predator could have downloaded exploitative materials for later use and offline sharing.

The only possible logical endpoint is a system where we scan each and every file regularly. This 'digital check-up' would run every time a file is modified, downloaded, or otherwise interacted with. This would mandate that a device functions only while online, but in our increasingly connected world, this should pose no problem. This system would protect our children like no other. The government would be able to scan not only for illicit CSAM but also for illegal content, terrorist propaganda, unhelpful misinformation, or simply undesirable material, which could then be reported to the proper authorities, actioned, and removed permanently. Implementation of this system should be viable with minimal resources and is truly the best way to ensure our children are safe from all angles. If you object to this new rule, you have already told us everything we need to know. A perfect, idealistic society would never tolerate secrets. A true citizen would never object to the protection of children. You either share everything the government wants to know, or you support the predators. It is as simple as that.

Finally, the UK's new Act ensures that anyone who "causes psychological harm amounting to at least serious distress" can be imprisoned for up to two years, which is a wonderful idea to silence those who dare to harm our children, even verbally. However, another fascinating potential use case of this law—one that excites me even more than protecting our children—is to silence undesirables. Using this law, one could foreseeably imprison anyone with whom the government disagrees, an excellent, unplanned side effect that we could all stand to benefit from; a side effect that will support our ideals of building a better, more stable, safer society for children and adults alike.

However, once again, the UK government is being too weak with its policies. We at The Gadfly look towards—and praise—Canada's proposed strong-arm approach: pre-emptively placing citizens under house arrest for things they might say, and imposing up to life imprisonment for things they did say. This is a wonderful part of a wonderful policy that will put away people who harm, or could potentially harm, children forever. All this is necessary in our quest to save children not only from our modern internet but from our modern world itself.

Let us be clear about the ultimate goal that this Act and our suggestions set into motion: the state must rightfully take its place as the ultimate parent. No longer will they be able to access the depravity of Pornhub and Reddit, the lyrical freedom of Spotify, or the rampant, unregulated "truth" of Wikipedia. No longer will they be scarred by ideas that differ from the official narrative. No longer. Yet, despite all the positives we have clearly presented here, there have been some complaints of 'censorship', 'tyranny', or 'building a global dystopian hellscape', but to those people, we must simply ask: what is the weight of a single child's tear compared to your so-called 'freedom'?



## Opinion: Imperative That World Leaders Agree to Raise Global Temperatures in Response to Titanic Foundering


